
OPERATING INSTRUCTIONS:

- Before use, connect USB cord to a USB port with 5V and 1A output (such as a car adapter, portable USB battery, computer or laptop computer) and charge until the green indicator over the mini USB socket turns on.
- Charge this light every month if not in constant use, and after each use if it is used often, to ensure longivity.
- Press the switch once for top spotlight, twice for front LED low power, three times for front LED high power and four times to turn off.

CAUTIONS:

- For indoor use only DO NOT use in or around tubs, showers, sinks, pools, hot tubs, or in a wet environment.
- Use only the recommended voltage and frequency requirements.
- · Keep out of reach of children.
- DO NOT operate light with wet hands.
- · Keep light away from hot objects.
- DO NOT leave light in direct sunlight for prolonged lengths of time.
